

In pursuance to directions contained in D.O letter No. Z-16025/3/2018-CPHEEO dt. 12th July, 2019 of Shri. Durga Shanker Mishra, Secretary, GOI Ministry of Housing and Urban Affairs Nirman Bhawan, New Delhi to implement the provisions of PEMSRA Act, 2013, regarding hazardous cleaning of Sewers/Septic Tanks, the Port Blair Municipal Council hereby constitutes an Emergency Response Sanitation Unit (ERSU) with the following officers of PBMC to meet emergency sanitation requests round the clock.

a)	Shri. Vijay Prasad Tiwari, Sanitary Officer, PBMC	Chairman
b)	Shri. Ajay Kishen Sr. Sanitary Inspector, PBMC	Member
c)	Shri. Vijay Kumar, Sr. Sanitary Inspector	Member
d)	Shri. Deepak Behari Chakraborty Sr. Sanitary Inspector, PBMC	Member
e)	Shri. Jatan Lall, Sr. Sanitary Inspector, PBMC	Member
f)	Shri. Pradeep Kumar Chowdhary, Sr. Sanitary Inspector, PBMC	Member

The Committee shall perform the following activities.

- 1) Cleaning of sewer/septic tanks shall be done with mechanical devices wherever feasible, however if human entry in sewer/septic tanks is required it should be done with full protective gears.
- 2) Undertake massive IEC campaign to educate employers and citizens about the provisions PEMSRA Act, 2013 with respect to hazardous cleaning of sewers and septic tanks.
- 3) Sanitation workers, who have been traditionally engaged in sewer and septic tank cleaning may be properly trained equipped and certified as Sewer Entry Professionals (SEPs)
- 4) Promote mechanized cleaning of sewers/septic tanks by keeping their contact number readily available for engaging in cleaning sewers/septic tanks at first instance, on priority.
- 5) Should not allow any person (s) into a sewer/septic tank other than a properly equipped SEP, duly authorized by ERSU. In case of any default, a FIR should be automatically lodged under PEMSRA, 2013 against the principal employer, contractor, Sanitary Inspector of PBMCs well as the individuals engaged in such hazardous task without proper authorization and equipment.
- 6) The Emergency Response Sanitation Unit (ERSU) shall frequently meet at fortnight intervals and take a stock of the situation.



NOTIFICATION

Port Blair, dated the 29th April, 2016.

No.76/2016/F. No. 1-82/2016-UD.— In exercise of the powers conferred under Section 18 of The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013, read with Section 2(I) (b) thereof, the Lt. Governor (Administrator), A & N Islands is pleased to hereby appoint Secretary, Port Blair Municipal Council (PBMC) to exercise the following powers and duties for implementation of the said Act in Port Blair Municipal area :-

1. a) Under the provision of Section 4(1) (a) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013" carryout a survey of insanitary latrines existing within the Port Blair Municipal limit and publish a list of such insanitary latrines within two months from the date of this Notification.
- b) Under the provisions of Section 4(1) (b) give notice to the occupier, within fifteen days from the date of publication of the list under Section 4(1) (a), to either demolish the insanitary latrine or convert it into a sanitary latrine within 06 (six) months from the date of this Notification.
- c) Under the provision of Section 4(1) (c) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013" construct, within a period not exceeding nine months from the date of this notification , such number of sanitary community latrines as it considers necessary, in the areas where insanitary latrines have been found.
- d) Under the provision of Section 4(2) (3) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013" without prejudice to the aforesaid provisions, adequate number of sanitary community toilets should be constructed under Port Blair Municipal Council within such period not exceeding three years from the date of this Act and also ensure arrangements for their hygienic upkeep at all times.

2. a) Under the provision of Section 5 (3) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013" if any occupier fails to demolish an insanitary latrine or convert it into a sanitary latrine within the period stipulated at sub-section 2 of Section 5, Secretary, PBMC having jurisdiction over the area i.e. Port Blair Municipal area, in which such insanitary latrine is situated, shall, after giving notice of not less than twenty one days to the occupier, either convert such latrine into a sanitary latrine, or demolish such insanitary latrine, and shall be entitled to recover the cost of such conversion or, as the case may be, of demolition, from such occupier in such manner as may be prescribed.
3. Under the provision of Section 7 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", Secretary, PBMC will keep a vigil that no person, local authority or any agency shall, from the date of this notification, engage or employ, either directly or indirectly, any person for hazardous cleaning of a sewer or a septic tank.
4. **Under the provision of Section 8 & 9 read with Section 21 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", Secretary, PBMC is conferred with the powers of Judicial Magistrate of the first class for the Code of Criminal Procedure, 1973.**
5. a) Under the provision of Section 11 (1) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", if PBMC has reason to believe that some persons are engaged or employed in manual scavenging within its jurisdiction, Secretary, PBMC shall cause a survey to be undertaken to identify such persons.
 - b) The content and methodology of the survey referred to sub-section (1) of Section 11 of the said Act shall be such as may be prescribed, and it shall be completed within a period of one month from its commencement.
 - c) After completion of the survey, Secretary, PBMC shall cause to be drawn up a provisional list of persons found to be working as manual scavengers within the jurisdiction of PBMC and fulfilling the eligibility conditions as may be prescribed, shall cause such provisional list to be published for general information in such manner, as may be prescribed and shall invite objections to the list from the general public.
 - d) Under the provision of Section 11 (5) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", any person having any objection, either to the inclusion or exclusion of any name in the provisional list published in pursuance of the Section 11 (4) shall within a period of fifteen days from such publication file an objection, in such form as PBMC may notify to the Secretary, PBMC.
 - e) Under the provision of Section 11 (6) of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", all objections received in pursuance of sub-section (5) of Section 11 shall be enquired into, and thereafter a final list of persons found to be working as manual scavengers within the local limits of PBMC, shall be published by it in such manner, as may be prescribed.
 - f) As soon as the final list of manual scavengers, referred to in sub-section (6) of Section 11 is published, the persons included in the said list shall subject to the provisions of sub-section (2) of Section 6 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", stand discharged from any obligation to work as manual scavengers.

6. a) On receipt of application as prescribed in sub-section (1) of Section 12 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", Secretary shall cause it to be enquired into either as a part of the survey undertaken under Section 11 of the Act or when no such survey is in progress, within 15 days of receipt of such application to ascertain whether the applicant is a manual scavenger.
- b) If the application mentioned in clause (n) is received when a survey under clause (f) (1) is not in progress, and is found to be true after enquiry in accordance with clause (n) action shall be taken to add the name of such person to the final list published under clause (l) and the consequences mentioned in sub-section (7) of Section 11 thereof shall follow.
7. Under the provision of Section 17 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013", and notwithstanding anything contained in any other law for the time being in force, it shall be the responsibility of Secretary, PBMC to ensure, through awareness campaign or in such other manner that after the expiry of a period of nine months, from the date of commencement of this Act :-
- a) No insanitary latrine is constructed, maintained or used within its jurisdiction, and
- b) In case of contravention of clause (i), action is taken against the occupier under sub-section (3) of Section 5 of "The Prohibition of Employment as Manual Scavengers and the Rehabilitation Act, 2013".
