The assessment will involve comprehensive structural analysis, including **Non-Destructive Testing (NDT)**, and will help determine any necessary retrofitting or reinforcement measures.

To enhance public safety and ensure the long-term sustainability of municipal structures, SVPMC has initiated a program to assess the structural stability of important buildings. The assessment will focus on evaluating the existing conditions of these buildings and identifying any structural weaknesses or vulnerabilities. The selected contractor will be required to conduct an in-depth analysis and submit detailed reports with recommendations.

Scope of Work: The structural stability assessment will be conducted on the following buildings:
