  - Miscellaneous Services.

### **Modes of Operation**

- > The operation of e-Nagarsewa application can be categorized in three modes.
  - Citizen Mode: As the name suggests it comprises of function provided to citizen to avail following services:
    - Citizen registration.
    - Profile creation
    - Apply for new water connection.
    - Apply for property tax assessment
    - Payment of Taxes
  - Counter Mode: It is the operator login provided for the officials/dealing assistant/CSC's for facilitating following services to the Citizen:
    - Revenue Collection: The citizen can approach the operator at e-Corner of PBMC or CSC to pay their taxes/rents etc.
    - Tax assessment: The operator assigned with tax assessment roles can perform data entry for property tax assessment.
  - Admin Mode
    - ► The admin user are assigned with roles to update various parameters of the application like changes in slab rate of taxes, user creation/modification, report generation, rebates updation etc.
